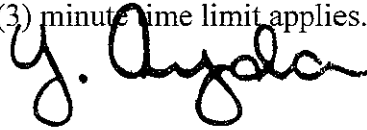

Members of the public may address the Board on any item, whether or not it is posted on the agenda. The purpose of this comment period is to provide the public an opportunity to address issues or topics

within the jurisdiction of Hidalgo ISD. For items not posted on the agenda, the Board may not deliberate or take action; however, members may direct staff to investigate or place the item on a future agenda. Additionally, members of the public may be recognized by the Board President to speak on posted agenda items at the time those items are considered. The same three (3) minute time limit applies.."
